Privacy Commitment

Unify Shading solutions is committed to respecting your privacy whilst providing the highest possible quality service and we recognise the need to know that your personal data is being lawfully processed and held in compliance with the General Data Protection Regulations. Personal data is any information that relates to a living individual who can be identified by that data and covers the information you may provide to us.

Purpose

Unify Shading solutions provides you with the information set out in this Privacy Statement, so that if you share your personal data with us you are aware of what we do with it.

Data Controller

Unify Shading solutions is the data controller of your personal data and we will only collect information in accordance with the General Data Protection Regulations. Our contact details are listed below.

Data Collection

We may collect information from you when you visit our website or when you email us, which includes:-

Use of Personal Data

We use the information that you personally provide to:

Improve the information and support we provide Process any requests you make

Provide you with information about products and services we offer

Conduct marketing research

In the interests of continually improving our services, we may contact you from time-to-time to inform you of new products and services that are relevant to you. We are committed to giving you the choice of whether or not to receive such information.

Sensitive Information

We will never collect sensitive information about you without your express consent.

Transfer of Personal Data

If we intend to transfer your personal data outside the EEA (European Economic Area) we will always obtain your consent first.

Sharing your Personal Data

Unify Shading solutions will not sell your personal details to anyone else.

Sharing Personal Data with Service Providers

Unify Shading solutions works with carefully selected Service Providers that carry out functions on our behalf. These include, for example, companies that help us with technology services, storing data, processing payments and delivering orders.

Unify Shading solutions will share personal data with these companies; we require them to keep it safe and they must only process the data in accordance with the instructions given by Unify Shading solutions the Data Controller.

Sharing Personal Data With Other Organisations

Unify Shading solutions may share personal data with other organisations in the following circumstances:

if the law or a public authority says we must share the personal data;

if we need to share personal data in order to establish, exercise or defend our legal rights (this includes providing personal data to others for the purposes of preventing fraud and reducing credit risk);

to an organisation we sell or transfer (or enter into negotiations to sell or transfer) any of our businesses or any of our rights or obligations under any agreement we may have with you. If the transfer or sale goes ahead, the organisation receiving your personal data can use your personal data in the same way as us; or

to any other successors in title to our business.

We will not share your personal details with anyone else unless you specifically request us to.

Tracking

We also collect information automatically about your visit to our web site. The information obtained in this way, which includes demographic data and browsing patterns, is only used in aggregate form, and as such cannot be used to identify you personally. Such aggregate information helps us to audit usage of our website and improve the service provided.

Security

Unify Shading solutions is committed to ensuring the security of your personal data. In order to prevent unauthorised access to or disclosure of your personal data we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

What rights do you have?

Should you wish to exercise any of your rights please email sales@unifyshading.com or write to us at the below address and tell us what right you wish to exercise. In some circumstances we may require proof of ID from you.

Rectification – Should any of the details we hold on you be incorrect, you have a right to request we rectify the error. Please contact us at the details above and we will rectify any errors.

Right of Access – You may ask us at any time for information about any personal data we hold about you. Any access request may be subject to a fee of £10 to meet our costs in providing you with the details of the information we hold about you.

Right to erasure – You can ask us to erase your personal data. We will not erase your personal data if it is still required for the purpose for which it was collected or if we are legally obliged to continue processing your personal data. It is important to note if you exercise this right we will keep a copy or a record of your request as it is our legitimate interest to show that you have exercised this right.

You also have the right to restriction of processing of your personal data and a right to object to processing of your personal data.

Right to complain to the Supervisory Authority – The Supervisory Authority in the UK is the Information Commissioner's Office (ICO) and you can complain to them if you are not happy with any aspects in relation to us processing your personal data. Their website is www.ico.org.uk
